

OUR EX-PRESIDENT HONORED

Our most hearty congratulations to Jacqueline Cochran, 99's president, 1941-1943, on the War Department's award to her of the Distinguished Service Medal.

First woman civilian to receive the DSM for services in this war, the citation reads:

*For exceptionally meritorious services to the Government in a duty of great responsibility from June 1943 to December 1944 as Director of Women Pilots, Head warters Army Air Forces. She directed the planning, programming and administration of all women pilot activities of the Army Air Forces, including the organization, training, and operations of the Women Airforce Service Pilots (WASP). Under her leadership the WASP performed, with the utmost loyalty and efficiency, multiple flying services in direct and effective support of the Army Air Forces which were of the greatest assistance and importance to the war effort of the nation. Further, her achievements in this respect and the conclusions she has carefully and wisely drawn from this undertaking represent a contribution which is of permanent and far-reaching significance to the future of aviation. Her vision, skill and initiative have resulted in services of exceptional value and importance to the country."

Announcement of the award was made March first. The date for the presentation of the medal is to be set later.





Margaret Chamberlain has returned to Shreveport from the WASP and is full of tales about the planes she flew. She has received her commercial and a BIG rating.



Mary Fearey, Odessa, Texas, reports hourly rate on Cub Trainer as \$7.50 solo, and \$9.00 dual; Cub Coupe as \$10.50 solo, and \$12.00 dula.

OVERSEAS NEWS

Congratulations to Dorothy Berendsen on her promotion to Captain. She is with air evacuation.

Bits from a letter dated "25 Feb, 1945". (She is picking up a bit of the European way of dating letters.)

"The most interesting parts of our trips is talking to the patients and hearing details of the fighting, how they were hurt, etc. One patient said he was carried for two miles over rocky country on an improvised stretcher. Then they had to cross a stream, so the medics tied him on a log and forded him across. Then he was tied to a tank that could take him only a mile; from there, on the hood of a jeep to a hospital. He insisted the plane ride was tops and he had ridden everything but a mule since he was injured.

"Almost all of our American soldiers are wonderful sports and good humored. They can see the funny side to a good many things and a laugh always bolsters them up.

"On one trip I had a patient who was irrational. I couldn't give him a sedative because he had a bad head injury and I spent over an hour sitting on the floor, holding him and talking to him.

"On most of our trips we start out early in the morning and fly to our destination, which takes from 50 minutes to two hours. Then we have to wait for our planes to be loaded. We are usually in flight with patients at noon. And there is the big problem of feeding. We carry 'D' ration bars, which are a concentrated vitamized chocolate. Sometimes we carry 'K' rations. If the air is rough, we find it best to hide the rations and tell them they will get coffee and sandwiches when we arrive. Fortunately the casualty rate hasn't been high."

Dorothy is also learning French.
