

ner meeting given by the Fort Worth Chapter, to which are invited all 99'ers, 490'ers and ex-Wasps.




The question of monsoring a Wing Scout Flight here in Jamestown was discussed and the group voted to give

A SNARF AND A DELUSION

In a recent issue of the NEWS LETTER, one of our chapters advocated support for the "Equal Rights" Amendment. It is splendid that members of the 99's are interested in legislation affecting women. I heartily concur in their desire to see women secure jobs on the basis of their ability. I am a firm believer that women can do a good piece of work in almost any field and that no field should be closed to women only because they are women.

Since we agree in our aims, let us examine this proposal known as the "Equal Rights" Amendment. It reads as follows:

"Equality of rights under the lew shall not be denied or abridged by the United States or by any state on account of sex."

"Congress and the several states shall have the power within their respective jurisdictions to enforce this article by appropriate legislation."

There are at least two serious objections to it. First, it is only "permissive". Second, it is dangerous.

Let me direct your attention to the second paragraph of the emendment. That statement means that until laws in addition to the above amendment are enacted by Congress or by your state, no acts of discrimination will be eliminated. Furthermore, it is unnecessary. There is nothing in the federal Constitution which would prevent enactment of legislation prohibiting discrimination on account of sex.

Now, for the more serious objection. It is dangerous for four vital reasons:

 It would imperil family support. It would either deprive the rife of the right to support from her husband, or give the husband an equal right to be supported by his wife.

2) It would deprive widows of protection. These legal rights would be threatened: a) Social Security benefits for widows; b) allowances for support during the settlement of the husband's estate; c) freedom of possession of the family home from creditor's claims.

3) It would vipe out health and welfere laws: a) State Minimum Wage Laws for women; b) Women's Hour Laws; c) Health and welfare benefits; d) all other specific legislation for women.

(The National Committee to defeat the Un-Equal Rights Amendment, 518 17th St., N.W., Weshington D.C., will send you upon request a list of the laws of your state which would be jeopardized.)

 It would prohibit enactment of any kind of special legislation for women, no metter how imperative it might be.

The opposition of such organizations as the National League of Women Voters, the National Councils of Catholic, Jewish and Negro Women, the League of Women Shoppers, Inc., National Women's Trade Union League of America, verious labor organizations and their auxiliaries, the National Consumers League, and many others including the National Board of the Y.W.C.A. of the USA gives added significance to the case against the amendment.

It is evident therefore that this amendment is not the solution to the problem of discrimination against women. What then is the answer? The answer is, first, write your senators and representatives opposing this amendment: second, to remove discrimination against women by specific bills for specific ills in each state.

Some of the differences in the treatment of men and women under state laws are for the benefit of the femily, while others are advantageous for the working woman. A few are definitely discriminator.

You can remove the discriminations against women now in your state laws if you will insist that your legislature change these few laws. In this way, you will preserve the benefits to the family while, at the same time, you will be eliminating legal discriminations. Let us not cormit the error of the boy in the fable who, in attempting to kill the fly on the baby's head, killed the baby as well!
