Thanks for the honor of being elected to comtinue as your president for 1946-47. I consider it a vote of confidence. Your cooperation during 1945-46 was wonderful and I accept re-election, knowing that I can count on the same co-operation from you during 1946-1947.

Many chapters were re-activated during the past year and this year we look forward to re-activating other chapters and also adding new ones. The responsibility of this work rests with you, Section Governors. Get in there and pitch. I warn you now that I shall be on your heels during this next year in an endeavor to make it possible for every NINETY-NINE member to have the advantage of local chapter association.

We start the year with twenty-six lively chapters. Soco- how about it? Thirty-six lively chapters by July 1st, 1946. Is it a bet?

IMPORTANT NOTICE: By action of the delegates assembled at the 1946 Annual Meeting on August 31st 1946 in Cleveland, Ohio, membership dues was increased to \$5.00. The additional 50/ will be allotted to the chapter from which it originates. Therefore Article V, Section 1 of the By-Laws as amended will now read as follows:

"Dues shall be \$5.00 yearly, payable to the NINETY-NINES at its National Headquarters, to be divided as follows: \$4.00 to the National Treasury, and 25% to the treasury of the Section and 75% to the treasury of the chapter from which it originates. \$1.00 initiation fee is required of new members payable to the NINETY-NINES at its National Headquarters."

AMENDMENTS

to CONSTITUTION AND BY-LAWS

During the 1946 Annual Meeting of the MINETY-MINES August 31st, 1946 in the Red Room of the Hotel Cleveland in Cleveland, Ohio, the following amendments to the Constitution and By-Laws were passed upon and become effective September 1, 1946:

AMENDMENTS TO CONSTITUTION AND BY-LAWS

CONSTITUTION

Art. II, Sec 1 (b)

A member who has changed her residence shall present to the chairman of the chapter organized to cover the territory into which she moves, or, if no such chapter exists, to the governor of the section into which she moves a letter of transfer from the chairman of the chapter from which she moves, or, if no such chapter exists, from the governor of the section from which she moves. Said letter of transfer shall be acted upon by the membership committee of the chapter into whose territory she moves, of, if no such chapter exists, by the membership committee of the section into which she moves and, if approved by said membership committee, such action shall establish her as a member thereof.

Sec 2 (a)

Any woman holding a current pilot's license or certificate of higher than solo grade or its equivalent in any country may on recommendation of the chapter membership committee, or, if no chapter exists, may on recommendation of the section membership committee become an ACTIVE member, which admits to all privileges and duties of the club including voting and holding office.

(b) (the last sentance to read)

She may be reinstated to ACTIVE membership, upon reinstatement of her pilot's certificate, through the regular channels of written application for membership by vote of the chapter membership committee, or if no chapter exists, by vote of the section membership committee.

Sec 3 (first two paragraphs to read)

At no time may a person become a meter of the NINETY-NINES, unless recommended by the chapter membership committee, or if no chapter exists, by the section membership committee, and unless she meets the requirements and agrees to the following:

Any female citizen of the United States or of foreign countries shall by vote of the chapter membership committee, or, if no chapter exists, by vote of the section membership committee, be eligible for membership in this organization, if she is of good character, and if, upon making her application she can show satisfactory evidence of the following:

(Balance of Section as now written)

Art. VII (Finance) Delete

Art. VIII will then be number VII, etc.

CORRECTION:

Art. VIII (now Art VII) Action taken at the 1941 Annual Meeting according to the minutes thereof amended this Article of the Constitution to read:

"There shall be an official insignia for qualified members and it shall be a point of honor for ex-members to refrain from wearing it."

BY-LAWS

- Art. III Change wording of last sentence in second paragraph to read:
 Previous to this, the Nominating Committee shall request each section and each chapter
 to submit a list of one name for each of the elective officers, from which lists they
 shall select the names to be submitted to the Secretary.
- Art. V, Sec 1
 Dues shall be \$5.00 yearly, payable to the MINERY-NINES at its National Headquarters, to be divided as follows: \$4.00 to the National Treasury, and 25% to the treasury of the section and 75% to the treasury of the chapter from which it originates. \$1.00 initiation fee is required of new members payable to NINETY-NINES at its National Headquarters
- Art. VI, Sec 1 (a) (last sentence in second paragraph to read)

 The chapter secretaries shall forward to the National Secretary the names of their delegates elected to sit in the Annual Meeting.
