

DUES DEADLINE - December 1st, 1946. All full-year and all half-year memberships (except those memberships accepted on the July 1st basis) are due for renewal at the new rate of \$5.00 per year on the FIRST DAY OF SEPTEMBER and according to the Constitution must be paid within three months from that date. If you sent in your remittance for \$4.50 before you received your notice, and additional 50d is necessary before your renewed membership will be in good standing.

MEMBERSHIP ROSTER: I have had several requests for a membership roster and the idea struck me that the January 1947 issue of the NEWS LETTER could be a membership roster. Would you like that?

So, if you want your name to be included in the membership roster and if you want to received the January issue of the NEWS LETTER containing the membership roster right up to date and hot off the press, BE SURE your dues are postmarked not later than mid-night, November 30th.

OPEN LETTER TO ALL MEMBERS

Last night interested citizens attended a hearing of reasons for and against the abatement of the Bay Meadows Airport, in San Mateo, California. The city council had been petitioned by residents of South San Mateo to abate the field asserting that the fliers made too much noise,

endangered the lives of the residents, lowered real estate values, and were a public nuisance.

After some four hours of debate by both sides, the city council tabled a motion for the abatement until further investigation could be made by an Aviation Commission (two in aviation, two non-flying residents, and one dis-interested citizen). It was suggested that other means might be found to satisfy the citizens demanding the abatement without going to such drastic extremes.

This has become a local crisis for pilots and potential pilots in this area, therefore, it would be interesting to hear from anyone knowing of similar proceedings in other cities and the results of such proceedings.
