

99 AIRMARKING LAUDED!

To show your efforts are not in vain, here is a reprint of the editorial from the August issue of "Business "

"Recent developments in electronics as applied to air navigation have been amazing to say the least. We accept the fact that we can easily fly from one place to another without seeing the ground. And the allto another without seeing the ground. And the all-seeing eye of radar can guide us to safe landings in the worst weather when we get there.

"But 'n spite of all the advances and progress, the fact remains that the great major'ty of l'ghtplane business flying is done with a map in mind. The average "Joe" likes to see where he is in reference to towns and railroad tracks.

"And even at that, who hasn't been lost? To be sure, most of us can find our position after a little puzzling over the map, but how nice it is to look down on a city or town and see its name in big friendly let ters on a roof-top. The all-too-rare air marker is always a welcome sight in weather - fair or foul.

"These skyway markers don't just happen; they have to be instigated, designed, located and painted. Unlike the airway beacons, which are federally owned and operated, the rooftop markers are the responsibility of each community. Aid in the form of paint, templates and specifications is often available from Uncle Sam or the State, but the basic job falls on the community

"Federal and state aviation officials encourage airmarking in every way that they can within their power. Private aviation groups, and notably the 99's, have

also been very cooperative. In Kansas, the 99's nave even traveled around the state and painted many of the markers with paint furnished by the CAA.

"Other groups have been equally interested and helpful -- but there is need for a better understanding among responsible people in many cities, towns, and villages of the importance of this program.

"Proponents of airmarking point out several advantages to communities that go along. Air travelers recognize as progressive any town that displays an airmarker and all towns, regardless of size, are shown on government maps if they are airmarked.

"This should prove of particular value to small communities located in the vicinity of parks, monuments, resorts or other scenic or recreation areaswhich would." otherwise not be shown. Businessmen in areas without adequate marking can do much to point out to officials the need and desirability of an airmarker. It isn't a costly proposition -- most can be done for about fifty dollars -- and the benefits to be gained are great.

"Let's all throw our weight behind those few far-sighted people who are working toward an end that could conceivably save our lives."

FLYING RESOLUTIONS FOR 1954

The 200 hour mark - one additional rating - perhaps both.

The 200 solo hour goaf is an excellent one, for, if a member has this time logged but cannot pass a flight physical, she may still maintain membership in the Ninety-Nines. While accumulating these hours, it may be possible to pick up another rating such as single engine sea, a ground instructor rating or, better still be sharp enough to pass the Commercial flight test at exactly the 200 hour mark. It can be done:

January is usually considered inventory time. Before the January meeting, have your Flying Activities Chairman make a list of all members, what ratings they have and how many hours they have. To so again at the end of the year and note the accomplishments. Have a small contest during the year and present an award if that works best. You may have other suggestions to stimulate local flying.

In any event, try to have all ideas worked up by the January meeting of your chapter in order to make use of the full year. At the end of 1954, let's see which Chapters can boast: Members with one additional rating 100%.

ISRAEL 99 REPORTS!

Not everywhere in the world are women fortunate enough, as in your country, to own and fly their private planes. Israel is among the less fortunate in this respect, having relatively few light airplanes (most of them owned by the Aero Club of Israel) and still fewer airfields. Nevertheless, Israeli sporting Aviation is on the upgrade and our girls and women are doing their best to be in it, participating in all the activities connected with aviation, like aero-modeling, gliding and power-flying.

Power-flying is done mostly on Piper Cubs PA-18's, . which belong to the Aero Club of Israel, as well as in French Nord "Noredrin" 4-seaters with retractable undercarriages.

There are today quite a few girls flying in this country, of which the writer was the first. It would be a good idea to start a chapter of the Ninety-Nines in Israel, but as most of the flying girls still serve in the Air Force, we shall have to wait some time until a sufficient number will be de-activated.

One of our female Club-members is a flying instructor and instructs youngsters in the summer flying camps.

Girls also excel in gliding. For this flying activity, we mostly use "Wrona" type elementary gliders, "Grunau-Baby" training types and "Olympia" advanced sailplanes. We also possess a Laister Kaufmann TG-4 2-seater, while the excellent Schweizer 122 2-seater, which was used extensively for training, was severely damaged some time ago, and it is almost impossible to obtain spare parts for the repairs.

Israel is topographically far from ideal for gliding, stretching as it does for 250 miles from north to south, across the prevailing wind.

Nevertheless, some fine achievements were recorded, and for one of them - a flight of 5 1/2 hours - one of our girls, Rina Levinson, of Tel-Aviv, was awarded the Rakir gliding trophy for 1952.

Our third activity is aero-modelling, this, being hobby and sport as well as science, serves in two capacities: on the one hand it creates airmindedness in the youth and supplies a training ground for "pre-full-size" aviation; on the other hand it constitutes a fine international sport, an outlet for creative energy and a part of aerodynamic science.

The number of girls among our modelling enthusiasts is quite large and girls took part in our second Aeromodelling Nationals held in July last, near Nazareth in northern Israel. By the way, this year we took part for the first time in an international competition when a team from Israel participated in the fourth World Model Glider Championships held at Bled, Yugoslavia, in August last.



The January meeting will be held in Apple Välley--a fly-in! It should be an enjoyable event as the desert is so very beautiful in the winter.




SAN DIEGO CHAPTER By: Dottie Sanders
