## President's Column

How time flies! There are so many things I must take up with you that I beg your indulgence for a long epistle.

First, I want to wish you all a very prosperous and flying filled New Year. Let's make 1970 a Year of enlightenment with APT, involvement, getting informed and finding new members.

Get APT. GARNETT HASTINGS reports that the pins denoting this accomplishment are almost ready and will be available along with plans for competition and recognition on a National basis. Be sure to watch for GARNETT'S column as I feel this is one of the most important items on your Ninety-Nine Agenda for '70.

Get INVOLVED. You individually represent the Women Pilet; of the World. You must assume the responsibility of getting current and staying abreast of the state of the art in our aviation environment. When things happen that could affect the future growth of General Aviation, make your thoughts known. As an example the FAA recently published a Notice of Proposed Rule Making (NPRM) 69-41 which dealt with Positive Control of Air Traffic at Terminal Areas. After reading this NPRM and reviewing the action FAA intended to take, your Executive Board unanimously voted to present an Official View of The Ninety-Nines to the FAA. My letter stating the Ninety-Nine stand is printed in this News. I urge you all to examine this Proposal, make your own decision and let it be known. I believe legislation that is too restrictive will adversely affect Aviation in general. We are all for Air Safety and support any measure that will offer some assurance of protected co-existence for all traffic. A disciplined use of Traffic Corridors is within the scope of possibility with proper electronics. Let's hope that the FAA and the Aviation Industry can come up with a plan which will be more compatible for all users in the near future.

Air pollution is another serious matter we are all living with whether we like it or not. If you inform yourselves on this matter or any other and want to take individual action, this is great. If you feel it should have International response, contact me or anyone on the Executive Staff with your proposal. Please remember TAKE NO ACTION

IN THE NAME OF THE NINETY-NINES, INC. without Executive Board approval. We are incorporated as a non-profit Corp. and this restricts our Ccrporate actions. The Federal Aviation Administration is always interested in your comments. If you oppose an FAA NPRM try to offer constructive criticism and alternative solutions.

Get INFORMED. With the advent of the computer age, Air Traffic is assuming new dimensions. Enroute Traffic will be controlled via satellite to a very precise degree. Flight plans will be computerized and zero-zero landings will be a fact. Airplanes will be pressurized, super-charged and/or turbine powered in the General Aviation field we are familiar with. The numbers of aircraft will double in the next decade and the number of licensed pilots will more than follow suit. Truly, Air Transportation is an integral part of tre World Transportation picture and the necessity to fly more will be a fact of life.

Get MEMBERS. With the present surge in licenses and the comfortable aircraft available, you are going to see more and more new faces at the airport. While at the airport getting APT or maintaining your proficiency, you are going to get to know these new female type pilots and will want to invited them to become Ninety-Nines. De proud of your Ninety-Nine membership. Learn about our history and the members who made it the great International Organization it is. ### **WORLD RECORDS**

By Virginia Trompson

To complete the picture of world records as published in our Anniversary Issue last month, let us look to see how you should go about making application to attempt a record, world or national.

The Federation Aeronautique Internationale, world authority for the certification of international records, requires that all official attempts be made in accordance with their Sporting Code.

Below is a condensed list of procedures which apply in general to all records.

#### 1. Sanction:

- a. Application—Must be applied for and granted by the National Aeronautics Association, Suite 610, Shoreham Bldg., 806 15th St., N.W., Washington, D.C. 20005.
- b. Time—Sanction request must be submitted to the Secretary, Contest Board at NAA Hdq. at least 30 days prior to the start of the record attempt.
- c. Valid—Sanction valid for a period of 90 days.
- d. Fees—Contestant or his sponsor agrees to pay the record fees.

  (NAA (NAA Members) Members)

Light Aircraft & \$100-\$200 \$125-\$300 Light Helicopters

Non NAA members' fees range from \$25 to \$50 higher. The price is lowered for additional records on the same flight. U. S. National Records—Sanction & Registration: 75% of International Fees.

Other Fees & Charges (Main Ones)

- 1. NAA Officials' Fees (\$50/Man/ Day-\$25/Half Day)
- 2. NAA Officials' Travel, Meals & Lodging.
- 3. NAA Telephone, Telegraph & Cable Costs.

#### 2. FAI Sporting License:

Valid one required. Available from NAA, Cost \$5/year.

#### 3. Planning Meeting:

Place—Decided mutually between contestant and NAA,

#### 4. Documentation:

The NAA Directing Official coordinates all details of documenting

the record and insures compliance with applicable FAI Rules.

#### 5. Performance Requirements:

Performance must better the existing record as follows:

Speed Records 1%
Altitude Records 3%
Distance Records 1%
Duration Records
(balloons only) 1%
Time-to-Climb Records
Maximum Payload

Records 500 Kilograms (1,100 lbs.)

#### 6. Record Groups:

Group I—Piston Engine Airplanes Group II—Turboprop Airplanes Group III—Jet Engine Airplanes Group IV—Rocket Engine Airplanes

Not applicable to helicopter records or to records for Speed Over Recognized Courses.

#### 7. Weight Class Records:

Light airplanes, business airplanes and helicopters are classed according to weight in full take-off configuration in the presence of an official observer.

#### 8. Provisional Claims:

If F.A.I. notified, provisional claims good for one week. Improvements on the first attempt within this period acceptable if they better the preceding claim by any margin.

#### 9. Certification:

After completion of record attempt, the supporting documentation is compiled and reviewed at NAA Headquarters.

### A 99 Looks At – And Listens To – The FAA

Seen any upside down wedding cakes lately? You will, we're afraid. It's the latest effort of the FAA to cut down on airport-proximity mid-airs. And it will affect us all.

Years ago the then-CAA innocently and helpfully took unto itself the task of providing guidance and assistance to the Wright Brothers' rapidly growing baby, Aviation. The baby turned into a giant and the CAA, now FAA, found itself having to direct and regulate, not just guide and assist.

The poor FAA sometimes feel that Frankenstein and Pandora's box have nothing on their bag of troubles.

And there is a feeling that general aviation has been assisted lately into an untenable position.

The situation was sparked by recent mid-air collisions and ignited by shock and panic after the Indianapolis Affair. The flames have been fed by irresponsible journalism such as that of JACK ANDERSON in Parade Magazine, which we personally read with hair standing on end, and the recent Huntley-Brinkley presentation over TV, about which we heard.

Faced with screams from the general public and pressure from Congress, the FAA has come up with some aerial geometry which will give the unsophisticated pilot a fit and may contribute ulcers to the more professional types.

Most of the aviation groups descended on Washington in a first-time solid front, all suggesting that a try, at least, be given to climb and descent corridors. Among the groups submitting the coridor-concept were AOPA, ALPA, NPA, 99s, WACOA, and we're sure there were others. But . . . the prospects do not look bright for corridors.

We'll try to pick out the high points in the Docket. If we get a few errors into our interpretation, we will be happy to be corrected. We personally are NOT very good at geometry.

First 22 large hubs will be affected, then 90+ "non-large" hubs, and eventually—all jet carrier-served airports.

Says the document, excerpted by your columnist, "The FAA has developed a plan which will accommodate the increasing number of IFR and VFR operations and reduce, to the extent possible, the risk of mid-air collisions."

Henceforth parenthetical comments are those of this writer.

You must have an ACT clearance to operate within a designated Terminal Control Area (which may be many miles in diameter.) (This doesn't necessarily mean IFR, it does mean positive control by ATC.)

Aircraft must be equipped with transponders, 2-way radios, VOR or TACAN receivers.

A reported ceiling of 1500 feet must exist in order to operate VFR to and from an airport within the TCA.

VFR transient traffic may operate through the TCA between specified altitudes at locations wrere ATC has resource capability to handle such traffic.

(Better read that one again.)

Notices in AIM, on charts, or both, will specify whether or not VFR traffic may operate through these areas. (You can't go through Miami TCA VFR any time, we think. Hope we're wrong.) If such operation is permissible, notices as to altitudes and hours for such operations will be specified.

"Non-large hubs" will permit VFR traffic at all hours. Other carrier-use airports will have climb corridors.

. . . . .

That's the essence. We suggest you get APT on you instrument ticket and set up a Transponder piggy bank—and good luck. We'll be puzzling around up there with you.

## AMELIA EARHART SCHOLARSHIP

Your January issue of the 99 News will be arriving about the time that the Sectional Amelia Earhart Scholarship chairman will be at her busiest. By January 15 all applications must be in her hands. She will have selected a committee of judges. This committee may be composed of other 99s or of other persons from her region who are competent to assist her in making the selection. They will screen the applicants. Each section will be permitted a number of candidates based on membership. For each 100 members, or major fraction thereof, the section is permitted one applicant. Those selected will be sent to me as Chairman of your A. E. Board of Trustees. They must reach me no later than February 15. I will then, immediately, send one copy of each application to each of the other members of your A. E. Board. They

will evaluate them and at a Board meeting, which will be held in March, the next screening will be made. These will then be submitted to the Honorary Judges for a final selection.

During this spring meeting the A. E. Board makes a final decision as to the number of scholarships which can be awarded. Since 1964 the Board has been able to award three scholarships each year from the fund. During this time a fourth scholarship has often been made available through the generosity of certain groups. The Michigan Small Race and the North Central Section have been such groups. The fund scholarships have increased from \$700 to the \$1000 offered this year. This has been made possible through the work of the chapter A. E. Chairmen who have raised money for the fund. As

you know, each year the scholarship is made up from two sources of monies. Half comes from the interest on the fund and half from the donations of that particular year. It should be mentioned that for each contribution to the fund, half of it goes into the invested monies of the fund and half goes into the scholarship for that year. Thus, if your chapter contributes \$10 to the A. E. fund, \$5.00 goes into the trust and \$5.00 is applied directly to the scholarships of that year. Each of us, thus, has a direct investment in each of our scholarship winners.

As you read this, the long process of selection of your scholarship winners is just beginning. The results will be made available at the national convention. Your interest, your attention, and your support are always invited.

## COMMITTEE REPORTS

FLYING ACTIVITIES Virginia Britt, Chairman

1968-1969 Review:

1968-1969 found Ninety-Nines participating in Air Races, free lance charter flights, mercy flights, closed course racing, championships, 2c-lb. flights, Treasure Hunts, Poker Flights, Derbies, European Tour of the FAI, Records, Proficiency Checks and the pursuit of higher ratings.

The Flying Activities Committee concentrated their efforts on the implementation of Project APT, a self-imposed annual proficiency test program designed to assist Ninety-Nines in improvement and maintenance of pilot proficiency. We owe thanks to GAR-NETT HASTINGS, JOYCE CASE and CAROL WADDELL for seeing this program trrough to fulfillment.

JUANITA DIESBOURG compiled an interesting report on setting light plane World Records. The report includes procedures, Groups and Classes of Record attempts, Fees and charges. 
